Private Well Flooding Guidance:

The main thing to know is that if flood waters have impacted a private well, individuals should not drink the well water or even wash with it until it has been tested. Individuals should contact Siouxland District Health Department to get their well tested (for free). If Siouxland is overwhelmed and not able to assist, there are steps in the document for doing an emergency shock chlorination.

Disaster Relief Team in Sioux City

The Southern Baptist Disaster Relief team is in Sioux City this week to assist residents who were affected by flooding in Riverside.

Volunteers will visit homes in the Riverside area, evaluate damage, and then assist in remediating the damage, including mold prevention.

All volunteers are easily identified with yellow colored apparel and identification and have completed a background check.

Residents who wish to use their services should call 712-255-5989, extension #2. Representatives will also be at the Riverside Flood Relief Resource Fair (more info. in the latter part of the guide).

Emergency Management - Woodbury County

Reporting Water Damage:

Residents with water damage, including basements outside voluntary evacuation areas, urged to report to the Iowa State Office of Emergency Services at <https://www.report-ia-state.orioncentral.com> to allocate appropriate resources to the area.

Road Closures:

- **Inspections - Sioux City Inspections Office - 712-224-5216**
 - Residents are reminded not to begin any recovery efforts until the home has been inspected. Resident's of Sioux City who haven't had their homes inspected yet, please call the Sioux City Inspections Office or visit them at 405 6th St., Mon-Fri.
- **Utility Restoration - MidAmerican Energy - 712-281-9180**
 - Residents seeking utility restoration to their homes in Riverside must schedule an inspection through Sioux City Inspection Services. Inspections can be arranged during normal business hours by calling Inspections Services.
- **Temporary Shelter and Assistance**
 - The Red Cross continues to operate a temporary shelter at Sacred Heart Church (5010 Military Road) for residents displaced by the flood. They remain available to aid as needed. The shelter may be reached at 712-233-1652, or by contacting the local Red Cross 712-252-4081.
- **Flood Assistance - Community Action Agency (CAA) of Siouxland - 712-274-1610**
 - The CAA of Siouxland has clothing vouchers, an emergency food pantry, and personal hygiene items. They also have vouchers for the Junior League's Discovery Shop, Mission of the Messiah and Goodwill.

Funding for Riverside Neighborhood Residents

The City of Sioux City Neighborhood Services Division is pleased to announce the creation of a program to assist owner-occupied households that have been impacted by flooding in the Riverside neighborhood.

The program addresses the following needs related to the flood: HVAC, mechanical, water heaters, electrical panels, and radon mitigation (federal requirement). Other items to be approved on a case-by-case basis. All assistance is income based (only taxable income counted). Income limits are on a sliding scale based on household size (ex: a family of four could not make more than \$79,950 per year in taxable income). If a household only receives social security benefits not taxed, they would likely qualify. Up to \$10,000 per household in the form of a grant will be available. The program is funded by federal, state, and local grants.

Neighborhood Services Division staff will start going door-to-door in Riverside on Tuesday, July 2nd with information related to the program. Staff will be dressed in red or blue City of Sioux City Neighborhood Services Division polos and will carry a City employee ID. If a resident is not at home, information will be hung on the front door handle.

Small Business Development Center

The Small Business Development Center provides counseling and training to small businesses including working with SBA to develop and provide informational tools to support business start-ups and existing business expansion.

SBA Disaster Relief Facts:

- Businesses of all sizes and private nonprofit organizations may borrow up to \$2 million to repair or replace damaged or destroyed real estate, machinery and equipment, inventory and other business assets. SBA can also lend additional funds to help with the cost of improvements to protect, prevent or minimize disaster damage from occurring in the future.
- Disaster loans up to \$500,000 are available to homeowners to repair or replace damaged or destroyed real estate. Homeowners and renters are eligible for up to \$100,000 to repair or replace damaged or destroyed personal property, including personal vehicles.
- Interest does not begin to accrue until 12 months from the date of the first disaster loan disbursement. SBA disaster loan repayment begins 12 months from the date of the first disbursement.
- SBA will provide one-on-one assistance to disaster loan applicants at Disaster Recovery Centers.

Woodbury County Approved for Individual Assistance Under the June Presidential Major Disaster Declaration

Gov. Kim Reynolds announces the approval of Woodbury County for Individual Assistance under the previously approved Major Disaster Declaration, FEMA DR-4796-IA, for Iowa counties where significant damage was sustained from severe storms, flooding, straight-line winds, and tornadoes that occurred June 16, 2024, and continuing.
